

Terms and Conditions – Membership

There are 12 classes of SFIA membership, each with specific requirements that must be met. Article IV.1 of the [SFIA Bylaws](#) contains the following requirements for eligibility.

Membership Categories

Manufacturer Member. Any individual, partnership, firm, corporation or entity regularly engaged in the manufacture on the North American continent of cold-formed steel framing members. Must be majority owned, a subsidiary or affiliated entity of a company that has been actively manufacturing cold-formed steel framing members for at least one year, or acquired a company with managers who have at least one year of experience in manufacturing cold-formed steel framing.

Contractor / Manufacturer Member. Any individual, partnership, firm, corporation, or entity in business on the North American continent employing labor as a contractor engaged in the installation of cold-formed steel industry products and also is engaged in the manufacture of cold-formed steel products for use in panels and assemblies that the company primarily installs.

Steel Mill Member. Any individual, partnership, firm, corporation or entity regularly engaged in making steel, on the North American continent of cold-formed steel framing members, connectors or accessories.

Connector & Accessory Manufacturer. Any individual, partnership, firm, corporation or entity regularly engaged in the manufacture on the North American continent of cold-formed steel framing connectors or accessories including fastener.

Coil Coater or Zinc Producer Member. Any individual, partnership, firm, corporation or entity regularly engaged in coating or providing coating materials on the North American continent of cold-formed steel framing members, connectors or accessories.

Steel Coil Supplier/Processor Member. Any individual, partnership, firm, corporation or entity regularly engaged in supplying steel materials on the North American continent of cold-formed steel framing members, connectors or accessories.

Panel and Truss Fabricating Members. Any individual, partnership, firm, corporation or entity regularly engaged in fabricating panels and/or trusses on the North American continent utilizing cold-formed steel framing members.

Equipment and Tool Manufacturer Members. Any individual, partnership, firm, corporation or entity regularly engaged in manufacturing equipment and/or tools on the North American continent for use by the cold-formed steel framing industry.

Supplier/Distributor Member. Any individual, partnership, firm, corporation or entity regularly engaged in supplying or distribution on the North American continent of cold-formed steel framing products.

Contractor Members. Any individual, partnership, firm, corporation or in business on the North American continent employing labor as a contractor engaged in the installation of cold-formed steel industry products. A Contractor Member must be a member of the Association of the Wall and Ceiling Industry.

Design Professional Individual or Corporate Member. Any individual, partnership, firm, corporation or entity in business on the North American continent engaged in the design and or specification of cold-formed steel framing systems.

General Member. Any individual, partnership, firm, corporation or entity in business on the North American continent involved in the cold-formed steel systems is eligible to become a General Member of SFIA only if it does not meet the terms and conditions of the other membership classes.
